MAXIMUM WIDTH OF 3 INCHES PER BINDER
DO NOT OVERSTUFF - MAY USE MULTIPLE BINDERS
FIRST DOCUMENT SHOULD BE AGENDA OR INDEX OF PLEADINGS
ALL DOCUMENTS SHOULD BE IN ORDER OF AGENDA/INDEX
DOCKET NUMBER AND DATE FILED MUST BE WRITTEN ON BOTTOM RIGHT OF 1ST PAGE OF ALL DOCUMENTS
