- **Attorney Client Privilege Issues in Bankruptcy and Intellectual Property**- The panel will discuss two important attorney client privilege issues in federal litigation: (i) privilege in parent-subsidary matters, with a focus on the Bankruptcy Court's recent remand opinion and the Third Circuit's opinion in *Teleglobe v. BCE*; and (ii) the "sword and shield" exception to the attorney client privilege and its use in intellectual property litigation.
